

MINUTES OF MEETING HELD 28th NOVEMBER 1983 IN THE COMMUNITY HALL, TRAWDEN

1. APOLOGIES: Apologies received from Mr.Robertson, Mrs.Armstrong, Mrs.Stonelake, Mrs.Ward and County Councillor Sargeant.
2. MINUTES: It was proposed by Mr.Knowles and seconded by Mrs.Robinson that the secretary's name should be included in the Minutes on the list of people present.
Minutes of meeting held 31st October approved and adopted.
3. MATTERS ARISING: Reported that a list of persons aged over 80 has been prepared and submitted to Pendle Borough Council.
4. CORRESPONDENCE:

Black Carr Mill - Letter from Mr.Kirby, Planning & Development Officer, explaining the situation re the future use of the site and suggesting that one or two members of the Neighbourhood Council meet him to discuss the idea of converting the site into a recreation area. Resolved to reply arranging appointment.

Mr.Schofield, Morecambe - Copy of Mr.Schofield's note on his lecture entitled 'Trawden before 1840' have now been received and it was resolved to ask the Librarian to retain a copy for historical records.

Shopping for Elderly and Disabled - Mrs.Stone reported that there is a special late-night opening at Asda and that voluntary bodies in Burnley and Nelson are organising transport but apparently no such scheme is operating in Trawden and Colne. It was resolved to try and establish some sort of contact with the organisers so that more satisfactory arrangements may be made in future.

Nichol House Farm - Letter from Health Department advising that the North West Water Authority seem reluctant to become involved with discharges on a formal basis. Mr.Knowles said he felt it was more a matter for the Rivers Division and offered to find out their address so that contact can be made direct.

Library Fencing - The Librarian has confirmed that the remaining sections of fencing will be removed.

Sign to Trawden on Keighley Road - The Borough Engineer has agreed to erect a sign to Trawden on Keighley Road for the benefit of people approaching the area from Laneshawbridge.

- Community Buses - Mr. Bleasdale stated he had attended a sub-committee meeting regarding the proposed community buses by the Lancashire Parish and Town Councils Area Committee and reported his interest in a suggestion to run mini-buses in rural areas with volunteer drivers. Resolved to keep the matter under review.
- Planting of Bulbs and Trees - Reported that all the daffodil bulbs have now been planted in various parts of the village and it is hoped that a further supply will be available next year. It was mentioned that permission had been given earlier in the year for trees to be planted down Chelsea and by the bus terminus and it was agreed to ask Leisure Services if they would be willing to plant some trees there but preferably more mature than those planted in the Spring.
