- 2. MINUTES: Minutes of meeting held 28th April approved and adopted.
- 3. MATTERS ARISING: Footpath at bottom of Dean Street No reply to our letter but the secretary said she had spoken to Mr. Hicks of the Highways Dept who had promised to look into the matter.

Potholes on Colne Road - The potholes have still not been repaired by the Gas Board and the Highways Dept have promised to contact the

Gas Board direct.

Parking of vehicles at Cottontree - This matter to be brought up again when Mr.Bleasdale is present.

Land at Well Head - This matter to be brought up again when
Mr.Foulkes is present.

Children's Playground - The Chaimman said he had inspected the new piece of equipment and felt it was a poor substitute for a roundabout, and he expressed the view that the playground as a whole is far inferior to others in the area. Mrs. Vaterworth described it as 'pathetic' and said there is not even a bench to sit on. Letter to be sent to Leisure Services saying that in view of the fact that at least 200 children are in the area there should be better facilities.

4. CORRESPONDENCE: Circular from Community Health Council regarding a meeting to be held in the Municipal Hall, Colne, when the future of Hartley Hospital will be discussed.

Outline planning application for the erection of 4 houses in Winewall.

- 6. REVISION OF MINUTES: Blocked gullies along Mire Ridge Reported that the gullies have not yet been cleared in spite of a previous request.

 Bank account Mrs. Waterworth asked about recent bank charges and the treasurer said she had changed the account to the abatement system and that any charges now incurred will be offset by interest.

 Dogs Mrs. Stone said she had made it known locally that she would report any dogs roaming loose or fouling footpaths to the dog warden.
 - 7. ANY OTHER BUSINESS: A resident of Lane House has complained about the stabling of two horses and a manure heap beneath her kitchen window. She has already complained to the Borough Council who have asked the owner for retrospectic planning permission, and has asked that the Neighbourhood Council oppose the application when it is received.

Mrs. Stone asked if planning permission was required when new windows were put in a house and it was generally felt that it was not required.

Mrs. Waterworth said that the light on the 'Give Way' sign at the bottom of Burnley Road was still not working and said she would contact the Council.

Mrs. Waterworth complained about the dumping of derelict cars at Peter Laithe Farm on Foulds Road. A complaint to be sent to the Planning Officer objecting to the eyesore and expressing concern at a probable expanding scrap business.

Church Flower Festival - Mrs. Stone reported that the display from the Neighbourhood Council will be sited in the church porch, and the one from the Social Committee on the left of the alter.
