1. APOLOGIES: Apologies received from Mrs.A.Armstrong.
2. MINUTES: Minutes of meeting held 24th September approved and adopted.
3. MATTERS ARISING:

Community Bus - Mr.Bleasdale attended the last meeting on 3rd October and reported that there seems to be some confusion regarding the gift of a bus from the Council. It had therefore been decided to leave further discussions in abeyance pending their next meeting on 7th November. Mr.Bleasdale said he would be unable to attend on that date and Mr.Haley said he would try to go in his place.

Parish Council Status - No reply as yet to our letter dated the 21st August. It was proposed that a further letter should be sent to the Town Clerk along with a letter to the Lancashire Parish and Town Councils Association informing them of the situation.

Community Hall, Trawden - The paving stone at the entrance to the Community Hall has still not been relaid and it was proposed that another letter of complaint should be sent to the Borough Engineer.
4. CORRESPONDENCE:

Black Carr Mill - Letters from the Planning & Development Officer and the Town Clerk advising that the Estates Department have been instructed to do all possible to purchase the land for the Council.

Christmas Gifts for the over 80s - Letter from the Town Clerk asking for details of people over 80. Mr.Haley has the matter in hand.

Mrs.Stone mentioned that last year Asda had a special late night opening for elderly and disabled people and that transport was provided by a voluntary organisation but that Trawden had not been included in the scheme. Resolved to contact Asda for confirmation of the late-night opening and for information regarding transport arrangements.

Remembrance Sunday - Letter from Town Hall. Mr.Robertson again offered to obtain a wreath from the British Legion and lay it at the Cenotaph during the service.

Pendle Re-employment Project - Invitation to attend the opening of new premises on Tuesday 20th November. Mrs.Stone or Mrs.Darcy may be able to attend.

'Give Way' sign, Burnley Road junction - Mrs. Waterworth reported that the light was not working and it was resolved to ask for it to be repaired.
