1. APOLOGIES: Apologies for absence were received from Mrs.Beverley Robinson and Mrs. Mary Waterworth.

2. MINUTES: The Minutes of the meeting held on the 29th June, 1987, were approved subject to an amendment on Standing Orders (Item 5.) which should have read "Part II" and not "Part III".

MATTERS ARISING

3. AEROMODELLERS: Discussion took place regarding the meeting held on the 11th August when it was felt that the outcome of this meeting was unsatisfactory. The Clerk was asked to write to the Town Clerk asking if a Bye-law could be passed restricting the use of the Recreation Ground for Aeromodellers to Tuesdays, Wednesdays and Thursdays.

4. PLANNING APPLICATION - 6 Flats, Lachman Road, Trawden. Objection was raised to the erection of these flats and the Clerk was asked to write to the Town Clerk voicing the Council's objections.

5. MEALS ON WHEELS: Further assistance was required for Meals on wheels in Trawden and it was agreed that a notice be placed in the Colne Times under the Trawden News.

6. SWIMMING BATHS IN NELSON: Requirements for the proposed swimming baths at Nelson were discussed and it was left to the discretion of each Councillor to enter his or her views on the Questionnaire provided.

7. THE following matters were under discussion and IT WAS AGREED that letters should be sent to the appropriate Authorities dealing with the matters concerned:-

Bus Shelters: These are a health hazard. Letter to the Borough Engineer.

Road Signs: Hill Top, Winewall and Burnley Road by St.Mary's Church. Letter to Borough Engineer asking signs showing the speed limit to be 30 m.p.h., be prominently displayed.

Grate at Hall Road Trawden: This is blocked.
