- 1. APOLOGIES FOR ABSENCE: Apologies for absence were received from Mrs. Mary
- 2. MINUTES: The Minutes of the meeting held on Monday the 30th November, 1987, were approved and signed by the Chairman.

3. MATTERS ARISING:

- (a) Co-option of new Councillor: Mr. Cecil Rycroft was unable to attend for co-option onto the Parish Council but will do so at the Next Meeting on the 29th February, 1988.
- (b) Agricultural Show: Letter to be sent to Mr. Stephen Land inviting him to attend the next meeting of the Parish Council and outline what kind of contribution the Parish Council can make towards the Show. Also to express the Council's keen interest in the Show and ask Mr. Land to reply in writing to the Clerk whether or not he wishes to attend the meeting.
- (c) Toilets at Bottom of Rock Land. Railing opposite Toilets at Rock Lane: Write again to Borough Engineer urging that repairs in both these matters be expedited as soon as possible.
- 4. ALLOTMENTS: After some discussion IT WAS AGREED that a letter should be sent to all Allotment holders inviting them to attend at 6.30 p.m. on Monday the 29th February, 1988, prior to the commencement of the Parish Council Meeting in order to discuss future arrangements for the Allotments. An Allotment Committee was formed and this comprises Mr. David Bleasdale, Mrs. Karen Galvin and Mrs. Doreen
- 5. AEROMODELLERS: The letter from Pendle Borough Council regarding the meeting to discuss bye-laws in relation to the flying of model aircraft on Trawden Recreation Ground was discussed and IT WAS AGREED that Mr. David Robertson would liaise with the Legal Department at Pendle Borough Council to arrange a mutually convenient date and time.
- 6. DEAN STREET: It transpired from the Meeting held on the 11th January, 1988, that work would be carried out to make up Dean Street to an adoptable standard.

- 9. NEIGHBOURHOOD WATCH: Mr. David Robertson reported on the Meeting which he and the Clerk attended at Nelson Town Hall. It was felt that not all areas lent themselves to this scheme but IT WAS AGREED that the Police should be approached to see if they would give a talk to residents in the Village with a view to a Neighbourhood Watch scheme being set up in Trawden. It was felt that stickers in house windows showing that a Neighbourhood Watch scheme was in operation could act as a deterrent to burglars.
- 10. TOURISM: After much discussion it was generally felt that tourism in Lancashire was very desirable but in Villages like Trawden it was extremely important that all buildings erected should enhance the character of the Village rather than detract from it. The residents of Wycoller have objected strongly to Miss Penelope Keith's proposal to provide 12 bedroom accommodation and this will not now proceed. It is now proposed to provide 3-4 self catering cottages on this land.

11. PARISH MATTERS:

Spiked Harrow on Recreation Ground: Mr. David Robertson has spoken to Leisure Services on this matter and the harrow will be moved as soon as possible.
